FULL-TIME

Infants.....	\$307.00
Young Toddler.....	\$295.00
Older Toddler.....	\$279.00
Preschool and Pre-Kindergarten.....	\$234.00

(\$279.00 until child is potty trained)

PART-TIME

Ages 3 and above

(Under age 3 is full-time ONLY)

2 full days minimum.....\$65.00 per day

SUMMER WITHDRAW

Families may pay \$65 a week per child to hold their spot until the start of the new school year.

FINANCIAL POLICIES

HOURS

The Child Care Center closes at 5:30 p.m. Late pick-up fees are charged if parents are late picking up their children. Fees are charged until they leave the building. Maximum number of hours of care per day may not exceed ten (10) hours.

CHECK POLICY

First Check Returned - \$20.00
Subsequent Checks Returned - \$30.00

After three checks are returned, only payment by cash or money order will be accepted.

ADDITIONAL CHILDREN

Additional Children - 10% discount on the older child(ren).

INSURANCE

The parent's insurance is PRIMARY for any accident occurring here. The Child Care Center has SUPPLEMENTAL coverage in case the primary insurance doesn't pay in full.

LATE PAYMENT FEES

Payments are due Friday by noon. A late charge of \$15.00 per week will be added to the account if not received by noon on Friday. A notice of dismissal will be issued if a balance is carried into a third week.

A minimum of two weeks notice must be given in writing to withdraw from the center. Regular weekly chargers are applied for two weeks from the date of notification regardless of whether the child is in attendance.
